Regulatory Compliance

- Digital visitor logs allow you to collect, verify, and store the visitor data you need like citizenship status or health declarations to help you maintain compliance with regulations like ITAR, C-TPAT, FSMA, ISO, and other good manufacturing practices.
- **Document signing** asks your visitors to sign any necessary agreements like NDAs or GMPs, keep a record of their signatures, and set expiration schedules for agreements that may need new signatures periodically.
- **Check-in process** can be configured to require visitors to view safety videos to set expectations for your visitors.

- **Contact database** automatically syncs with your employee directory, granting and revoking access based on membership.
- Secure single sign-on (SSO) allows you to set customizable password parameters, or magic link access options for employees.
